MOTION FOR ORDER EXTENDING TIME OF CANCELLATION OF  
LOUISIANA POLICIES OF LIGHTHOUSE EXCALIBUR INSURANCE COMPANY  
UNTIL JULY 1, 2022, AT 12:01 A.M. CST

NOW INTO COURT, through undersigned counsel, comes James J. Donelon, Commissioner of Insurance for the State of Louisiana (“Commissioner” or “Liquidator”), as Liquidator of Lighthouse Excalibur Insurance Company (“Lighthouse Excalibur Insurance”), through his delegated and court-appointed Receiver, Billy J. Bostick (“Receiver”), who respectfully requests an order extending the time of cancellation of the Louisiana Policies of Lighthouse Excalibur Insurance, and respectfully represents as follows.

1.

On April 5, 2022, this Court issued an order placing Lighthouse Excalibur Insurance and related insurance entities in rehabilitation and appointing the Commissioner as Rehabilitator, and Billy J. Bostick as Receiver of Lighthouse Excalibur Insurance and related insurance entities in accordance with La. R.S. 22:2001, et seq.

2.

On May 23, 2022, with a finding of insolvency, this Court issued an order placing Lighthouse Excalibur Insurance in liquidation and appointing the Commissioner as Liquidator, and Billy J. Bostick as Receiver of Lighthouse Excalibur Insurance (“**Lighthouse Excalibur Insurance Liquidation Order**”).

3.

With regard to the Louisiana homeowners’ insurance policies issued by Lighthouse Excalibur Insurance (“**Louisiana Policies**”), the Lighthouse Excalibur Insurance Liquidation Order provided that the Louisiana Policies “shall be cancelled follows:

(a) All insurance policies issued by Lighthouse Excalibur Insurance in the state of Louisiana are cancelled upon the earlier of (i) thirty (30) days after the date this Order of Liquidation is entered, at 12:01 a.m. local time of the insured or policyholder of such direct policy or certificate of insurance; (ii) the expiration date of any such direct policy and/or certificate of insurance for which timely notice was given by Lighthouse Excalibur Insurance, if the expiration date is sooner than thirty (30) days after the entry of this Order of Liquidation; or (iii) the date the insured or policyholder of any such direct policy and/or certificate of insurance replaces the direct policy and/or certificate of insurance, or effects cancellation, if the insured or policyholder does so within thirty (30) days after the entry of this Order of Liquidation; and,

(b) All executory contracts of Lighthouse Excalibur Insurance may be enforced, cancelled or modified by the Liquidator or Receiver in their discretion or as otherwise ordered by this Court.”

4.

There are currently approximately 25,000 Louisiana Policies in-force which will cancel on **June 22, 2022, at 12:01 a.m. CST, unless such cancellation date is extended by this Court.**

5.

As a consequence of the impending policy cancellation date, the residual market insurer, Louisiana Citizens Property Insurance Corporation (“**Louisiana Citizens Insurance**”), La. R.S. 22:2291, et seq., has been inundated with applications from Louisiana homeowners for replacement insurance coverage, which despite diligent and good faith efforts by Louisiana

Citizens Insurance and the agents' network, Louisiana Citizens Insurance will not be able to completely process all applications by **June 22, 2022**.

6.

Therefore, in an effort to avoid during hurricane season a lapse or a gap in the insurance coverage of thousands of Louisiana homeowners, the Commissioner respectfully requests an extension of the current insurance policy cancellation date for a period of nine (9) days, or from **June 22, 2022**, at 12:01 a.m. CST, until **July 1, 2022**, at 12:01 a.m. CST, and that the Lighthouse Excalibur Liquidation Order be amended to require as follows:

(a) All insurance policies issued by Lighthouse Excalibur Insurance in the state of Louisiana are cancelled upon the earlier of (i) thirty-nine (39) days after the May 23, 2022-date the Order of Liquidation was entered, at 12:01 a.m. local time of the insured or policyholder of such direct policy or certificate of insurance; (ii) the expiration date of any such direct policy and/or certificate of insurance for which timely notice was given by Lighthouse Excalibur Insurance, if the expiration date is sooner than thirty-nine (39) days after the entry of the Order of Liquidation on May 23, 2022; or (iii) the date the insured or policyholder of any such direct policy and/or certificate of insurance replaces the direct policy and/or certificate of insurance, or effects cancellation, if the insured or policyholder does so within thirty-nine (39) days after the entry of the Order of Liquidation on May 23, 2022; and,

(b) All executory contracts of Lighthouse Excalibur Insurance may be enforced, cancelled or modified by the Liquidator or Receiver in their discretion or as otherwise ordered by this Court.

**WHEREFORE**, James J. Donelon, Commissioner of Insurance for the State of Louisiana, as Liquidator of Lighthouse Excalibur Insurance Company, through his delegated and court-appointed Receiver, Billy J. Bostick, prays that this Court grant this motion and issue an order extending the time of cancellation of the Louisiana Policies of Lighthouse Excalibur Insurance Company as requested herein.

**ORDER EXTENDING TIME OF CANCELLATION OF LOUISIANA POLICIES  
OF LIGHTHOUSE EXCALIBUR INSURANCE COMPANY UNTIL  
JULY 1, 2022, AT 12:01 A.M. CST**

Considering the Motion for Order Extending Time of Cancellation of Louisiana Policies of Lighthouse Excalibur Insurance Company Until July 1, 2022, at 12:01 a.m. CST, filed by James J. Donelon, Commissioner of Insurance for the State of Louisiana (“**Commissioner**” or “**Liquidator**”), in his capacity as Liquidator of Lighthouse Excalibur Insurance Company (“**Lighthouse Excalibur Insurance**”), through his delegated and court-appointed Receiver, Billy J. Bostick, and for good cause shown:

**IT IS ORDERED, ADJUDGED, AND DECREED** that the Liquidator and Receiver’s motion is **GRANTED**; an Order Extending the Time of Cancellation of the Louisiana Policies of Lighthouse Excalibur Insurance until **July 1, 2022**, at 12:01 a.m. CST., is hereby entered;

**IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that the Lighthouse Excalibur Insurance Liquidation Order entered on May 23, 2022, is amended and the Louisiana


homeowners' insurance policies issued by Lighthouse Excalibur Insurance shall be cancelled as follows:

(a) All insurance policies issued by Lighthouse Excalibur Insurance in the state of Louisiana are cancelled upon the earlier of (i) thirty-nine (39) days after the May 23, 2022-date the Order of Liquidation was entered, at 12:01 a.m. local time of the insured or policyholder of such direct policy or certificate of insurance; (ii) the expiration date of any such direct policy and/or certificate of insurance for which timely notice was given by Lighthouse Excalibur Insurance, if the expiration date is sooner than thirty-nine (39) days after the entry of the Order of Liquidation on May 23, 2022; or (iii) the date the insured or policyholder of any such direct policy and/or certificate of insurance replaces the direct policy and/or certificate of insurance, or effects cancellation, if the insured or policyholder does so within thirty-nine (39) days after the entry of the Order of Liquidation on May 23, 2022; and,

(b) All executory contracts of Lighthouse Excalibur Insurance may be enforced, cancelled or modified by the Liquidator or Receiver in their discretion or as otherwise ordered by this Court.

**IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that all provisions set forth in this Court's prior orders issued in this proceeding, including the Order of Rehabilitation issued April 5, 2022, and the Lighthouse Excalibur Insurance Liquidation Order entered on May 23, 2022, shall remain in full force and effect to the extent they do not conflict with this Order Extending the Time of Cancellation of Louisiana Policies of Lighthouse Excalibur Insurance Company, or Louisiana law governing the liquidation of insurers.
